

FROM THE AGENCY DIRECTOR

Fiscal Year 2008 was a year of exciting challenges and growth for Catholic Charities Bloomington. We saw an increased need for each of our programs: referrals, school counseling and outreach counseling; challenging us to provide services in the most effective ways possible.

We began counseling services at St. Charles Catholic School in Bloomington, and it quickly grew throughout the school year. In the spring semester we began providing counseling and assessment services at Pinnacle School, a private Bloomington school that primarily serves students with learning disabilities and other learning challenges. Meanwhile, we continued our

school programs at St. Vincent de Paul School in Bedford and at St. Ambrose School in Seymour.

It was also a year of increased collaboration with other agencies. We partnered with Big Brothers/Big Sisters, the Boys and Girls Club, and Oak Tree Counseling to provide a program for boys, *Passport to Manhood*, and expanded our services to the residents of Martha's House, Bloomington's homeless shelter. We provided supervision and support for counseling at Bloomington Area Birth Services and continued services at St. Vincent de Paul parish in Bedford and St. Agnes parish in Nashville. We also reached out to the Latino community by continuing to employ a bilingual, Spanish-speaking therapist, Luis Romero. Counseling services in the Seymour deanery were enhanced with the employment of long-time Seymour resident and St. Ambrose parishioner, Claudia Dominick.

Last June, floods created serious damage for St. Martin of Tours parish and Martinsville residents. Our agency provided mental health services and case management immediately after the storm and will continue to do so for as long as they are needed. The archdiocese is employing a skilled Catholic Charities relief worker, operating out of St. Martin of Tours, to respond to the physical needs of the residents, coordinating home re-building and volunteers. We know complete recovery will take several years.

The funding for professional mental health services does not always expand as rapidly as the need. They are critical that we maintain stable funding in order to not interrupt services in any way. We are able to maintain this stability through several key sources: the archdiocese, United Way, individual donors, and by the fees we collect from our clients and insurance coverage for our services. We greatly appreciate all those who have supported us through contributions during this past fiscal year. We could not exist without this support.

Sometimes real life issues threaten the ability of a student to be a successful learner, form healthy relationships, grow in confidence and understanding, and demonstrate behavior that reflects positive values. Two areas of service address these issues.

Social Skills Enhancement Groups and individual supportive counseling are offered in a more traditional therapeutic environment, provided on a weekly basis to students. In addition, consultation services for teachers and parents are available to schools and students throughout the area served by the agency. Experienced staff offered psycho-educational testing to assess children's learning needs.

For some students, navigating the social circles at school and trying to fit in is a great challenge. Whether they are new to the school, naturally quiet, or perceived as different in some way from their classmates, these children often feel left out.

Lunch bunch groups were started at St. Charles during the 2007-08 school year to help students with social skills in an environment that is fun, engaging and involves feedback from a trained counselor. Students made progress in interacting with the other children in the lunch bunch, in the classroom and on the playground. Many students remarked that lunch bunch was one of their favorite things at school because it gave them a place where they felt like they fit in. The positive response to this program proved that learning about social skills and how to be a good friend is "cool" after all.



Outreach Counseling and Education, and Psychological Services

2,000 hours of counseling provided by Catholic Charities Bloomington in four office locations:

- Bloomington
- Seymour
- St. Agnes parish (Nashville)
- St. Vincent de Paul parish (Bedford)

The hours reported above are face-to-face counseling hours, not school counseling hours, and do not include staff time spent in contact with various agencies, schools, and other health care providers to facilitate client treatment. It also does not include time for travel or documenting care, which is often significant.

HELP.

Professional mental health providers deliver individual, couple, family and group counseling to all ages for a variety of mental health issues. These services are also available through a bilingual counselor to persons whose primary language is Spanish. Educational programs for families and groups are offered in topics such as building healthy families, stress management, and alcohol and drug issues in youth and families.

As a counselor of Catholic Charities, Peggy York-Garcia provides professional support to the local Rachel's Vineyard Retreats and Rchel's Network. Rachel's Vineyard programming focuses on healing for people who have been affected by the experience of abortion. Often when an individual has had a child, (or even a grandchild, niece or nephew) aborted, that person may experience symptoms of Post Traumatic Stress Syndrome, as Post Abortion Syndrome, which can include severe depression, anxiety, and social isolation that may persist for years.

Referral Services

Daily the agency is called upon to provide consultation and assistance in finding appropriate mental health services or other basic needs for anyone in the Bloomington Deanery. This consultation is offered to anyone who contacts our agency, to the staff in the Bloomington Deanery parishes, and to the community-at-large.

"He's on the track team!" said Karen. I had just asked her how her son was doing. She was coming into the office to pick up Josh, who was seeing one of several student therapists and psychological examiners who come to our agency to gain counseling experience and hone their psychological testing skills.


This counselor-in-training had been involved with Josh, a middle schooler, his family and his school for several months. Seeing his stepmother's smile and hearing her description of his academic and social improvements at school made me think back to a phone conversation I had had with her over a year ago. As I was returning to Bloomington one rainy evening from Indianapolis, she frantically reported that Josh had gotten upset and ran away. At that time he had just started middle school, had only been with his dad and stepmother a short time, and was having a difficult time adjusting. He was often angry, and his parents and I both sensed an underlying deep sadness.

The family worked hard in therapy. Josh's school implemented recommendations we made after testing. Josh sometimes appreciated all these efforts and sometimes did not.

Helping families work through stressful times can be very challenging, but being part of a family's journey as they turn challenge into opportunity and success can only be described as grace filled. These are the experiences that make me humble and able to acknowledge our agency's ability to create hope in many lives.

Collectively last year all five agencies served more than 104,000 persons with the combined expenses of \$7.7 million and revenues of \$8.8 million. The total revenue amount includes a one million dollar capital grant from United Way of Central Indiana to help fund a new family homeless shelter in Indianapolis. Effective July 1, 2008, St. Elizabeth/Coleman Pregnancy and Adoption Services became part of Catholic Charities Indianapolis, with David Bethuram serving as the agency director of this expanded agency. We are combining the strengths of each agency to deliver innovative services to complete adoptions and provide professional support for women experiencing unplanned pregnancies in central Indiana. It also allows us to become better stewards of our resources, particularly in the areas of fundraising, accounting and administrative support.
